

## **Ohio Soybean Council's Precision Ag Reviews Facebook Sweepstakes**

NO PURCHASE IS NECESSARY TO ENTER OR WIN. A PURCHASE DOES NOT INCREASE THE CHANCES OF WINNING.

**1. Eligibility:** Sweepstakes (the "Sweepstakes") is open only to those who sign up at the online sweepstakes page and who are 18 as of the date of entry. The sweepstakes is only open to legal residents of the fifty (50) United States and is void where prohibited by law. Employees of the Ohio Soybean Council (the "Sponsor") their respective affiliates, subsidiaries, advertising and promotion agencies, suppliers and their immediate family members and/or those living in the same household of each are not eligible to participate in the Sweepstakes. The Sweepstakes is subject to all applicable federal, state and local laws and regulations. Void where prohibited.

**4. How to Enter:** The Sweepstakes must be entered by submitting a review on the Precision Ag Review's website (<http://precisionagreviews.com/>). The entry must fulfill all sweepstakes requirements, as specified, to be eligible to win a prize. You may enter only once and you must fill in the information requested.
